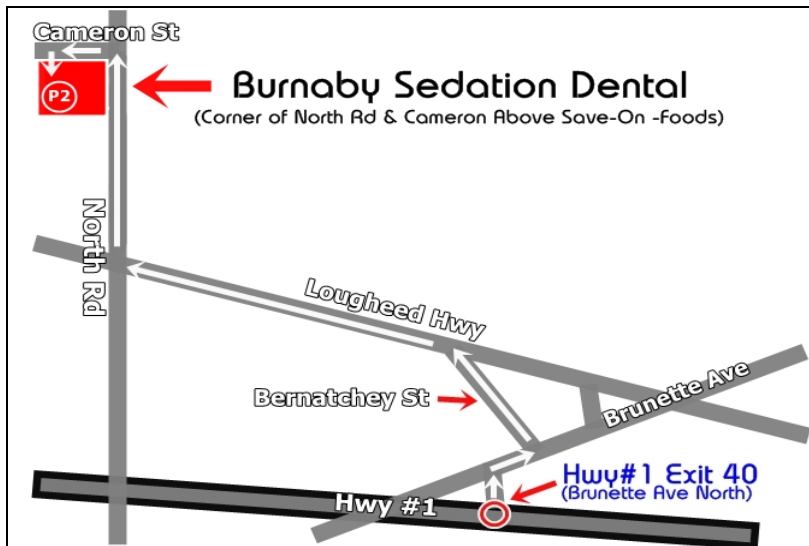

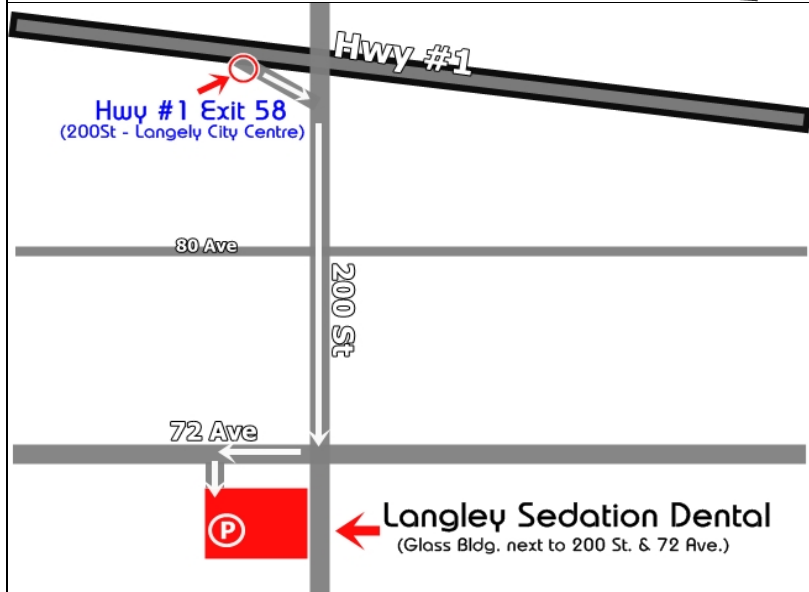

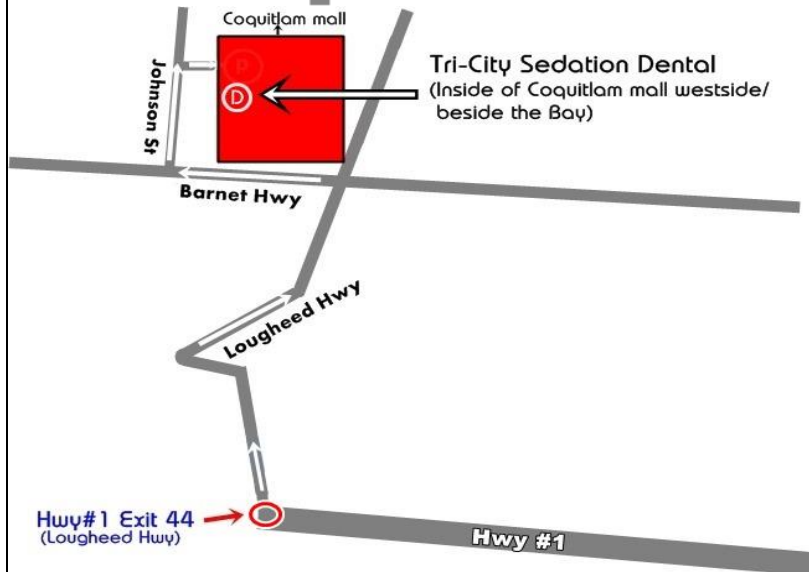
### To Burnaby Office
